## LEMPSTER RESIDENTS:

A notarized statement from the Lempster Town Office is REQUIRED. The proof of residency must have the current date and is required for all new students entering Lempster Community School whether there are siblings in the school or not. Per district policy.

## **Proof of Residency Documents**

Proof of residency documents are documents that indicate where a parent or guardian currently resides. Drivers licenses and passports are NOT listed as proof of residency documents because they remain in effect for long periods of time and may not list a current address even though the law requires that the addresses be kept up to date. Lempster requires two different proofs of residency.

Acceptable proofs of residency include:

- Recent property tax bill
- Current signed lease agreement
- Current purchase and sales agreement (if moving to the District)
- Recent rent receipts;
- Recent electric, gas or oil bill;
- Recent Bank statement
- Recent credit card bill

For parents who are divorced or for guardians, the District **requires** copies of the parents and guardianship orders.
