# Lempster Community School Library Approved Meeting Minutes

Call to order K. Caron

The meeting was called to order at 5:20 pm by Ms. Caron, chair.

Review of minutes from (12.5.23)

Board

Rachel Tirrell made a motion to accept the minutes of 12.5.23, second by Bruce Cragin. All were in favor, with Kelly Caron abstaining.

## Review of nonpublic minutes from (12.5.23) Board

Jessica Hooper made a motion to accept the nonpublic minutes of 12.5.23, second by Rachel Tirrell. All were in favor, with Kelly Caron abstaining.

Guests: Mr. Derek Tremblay and Lisa Sweet from Mount Royal Academy

Mr. Lewis introduced our guests and Mr. Tremblay described the school, where he has been since 2009. Ms. Sweet has been at the school for 5 years.

Mount Royal Academy is a classical catholic education, predicated on partnership with parents. You don't have to be catholic to attend school there. The school was founded as an independent catholic school with no direct affiliation with the diocese. They employ up to 30 staff members with a school population of 195 students, elementary through high school. They do not have special education, as they do not receive Title I funds, but they work closely with the Sunapee District for those services. They currently have 141 alumni. They offer art, sports, theater, and music, but do not offer technology.

The board then asked questions of Mr. Tremblay and Ms. Sweet.

They use the Math in Focus program for elementary. 88% of the graduating students attend college. Class size averages 15.

Ms. Caron asked about their procedure with special needs students. Ms. Sweet answered that they have a close working relationship with Sunapee School District. She went on to explain the formula of IEP/ISP's and the private versus public school funding of special education services in a district.

Ms. Tirrell asked what would happen if you had a student who you could not provide services for? Mr. Tremblay answered that they would make every effort to find services for that student. They don't always have speech or occupational therapy services, but they always try to find those services. Occasionally, they can find a private foundation to help with that. It is conceivable that they may be unable to accept a student with special needs.

Ms. Caron asked about the costs surrounding sports, uniforms, sports fee, and fundraising. They answered that the approximate cost would be \$1000.

Mr. Caron also asked who would be signing a contract to attend their school, the parent, district? Mr. Tremblay answered that it varies, but always there is a contract between the parent and the school.

Mr. Lewis asked about tuition fees and what if a parent could not pay? Some families may use Education Freedom accounts, and the district can make up the difference, it varies.

Mr. Cragin asked about teacher certification. Mr. Tremblay addressed that and mentioned that they have an internal process

Mr. Cragin also asked about library services. Ms. Sweet stated there are books to be found, but there is no dedicated library space, but all students get a library membership to the Sunapee Town Library.

**Public comment:** Amy Murrary (1st grade teacher), Selena Liete, Jennifer Gildner-Blinn (art teacher) were present.

Ms. Liete suggested that we renew the IXL math program, as it is helpful for her student and allows practice and parental support. She also mentioned Thinkwave and that assignments were previously shared there and that no longer happens. It appears that now the program is typing club and it isn't as useful as the previous program.

She inquired about school board meeting minutes and agendas being posted timely, somewhere online. Mr. Lewis answered that Mr. McNicholas is currently working on having that information on the new website so that current and (recent) past minutes can be found easily.

The broken playground slide was also addressed, Mr. Lewis updated her on the progress, and Ms. Leite has volunteered to help with that project.

She also inquired about being able to view the solar tracking costs and energy output information once that is online. Mr. Lewis stated that as it is public information, that is the plan.
